This puppy must be spayed or neutered by 9 months of age and documentation of the procedure from the attending veterinarian must be supplied to Leslie Harman.

Harman Corgis, Wayne & Leslie Harman, represents that this dog is in good health to the best of our knowledge. At the time of purchase and has been immunized with the following vaccinations: Canine Distemper, Adenovirus Type 1 (Hepatitis), Adenovirus Type 2 (Respiratory Disease), Parainfluenza, Parvovirus, and Bordetella. The fact that the puppy has been immunized does not guarantee immunity and **MUST** receive a series of vaccinations with boosters. The seller will provide the buyer with records of vaccinations and deworming. The new owner is responsible for completing ALL necessary vaccinations and must do so to fulfill the health guarantee. The puppy has routinely been dewormed with Pyrantel and Safeguard. The seller of this puppy guarantees the puppy to be in good health at the time of the sale and for the first 72 hours after the date received. The puppy must be taken to your veterinarian within 3 business days after receiving the puppy. If the buyer fails to have the puppy checked by a veterinarian within one week, the buyer agrees that this puppy was in good health at the time of purchase. If the buyer's veterinarian finds the puppy to have a serious or chronic health issue or in poor general condition, the seller will replace the puppy with another of comparable quality within a reasonable period of time. The seller reserved the right to a second opinion by a veterinarian of the seller's choice. Puppies undergo stress during moves to their new homes and can pick up a common treatable sickness such as, but not limited to, kennel cough, pneumonia, hypoglycemia, coccidiosis, allergies, giardia, parasites, mites, etc. These conditions are all treatable and so do not warrant an exchange in a puppy. The seller is NOT responsible for any vet bills or expenses. If the puppy dies, the buyer will provide the seller with a veterinarian's diagnosis and cause of death. The seller has the right to have the dog examined by a second veterinarian on their choice. If justifiable by both vets, the puppy will be replaced by a puppy of equal quality, price and sex.

The seller guarantees the puppy for one year against genetic defects that would make the puppy unsuitable for a family pet. The buyer understands that slight genetic defects are not life threatening and therefore not covered such as a hernia, undescended testicle, non perfect bite, etc. Injury is beyond the sellers control and can not be guaranteed. If such an inheritable disease is found by your veterinarian, the buyer will be entitled to a replacement puppy of comparable quality and sex. The seller reserves the right to a second veterinarians opinion by a veterinarian of their choosing at the expense of the seller.

If for any reason during the pet's life, the buyer needs to find a new home for the dog, the seller will assist with finding the pet a new home or take it back rather than see it placed in a shelter. Under no circumstances may this puppy at any age be relinquished to a pound or rescue. We can help in rehoming from your location by advertising on social media and our website. In this case the buyer would receive all funds received from the adoption and be involved in the adoption process from their location. If the breeder is required to take back ownership of the puppy and be responsible for rehoming from our location, the original buyer will have no claim to any funds received from the adoption. If the buyer rehomes the puppy on their own the spay – neuter contract is still in full effect and they must provider us with proof of spay or neuter even if performed by the second owner.

The buyer is responsible for all shipping costs.
